CONDITIONS OF ENTRY

1. Information on how to enter the Promotion and the prize form part of these Conditions of Entry. Participation in this Promotion is deemed acceptance of these Conditions of Entry.

The Promotion is open to individuals who:

- (a) Are residents of Australia (excluding TAS and VIC); and
- (b) Entrants under 18 years of age have obtained their parent or guardian's consent to enter the Promotion on these Conditions of Entry; and
- (c) Are not employees (or immediate family of such employees) of the Promoter, or any of its related corporations or any of the agencies associated with the Promotion (including suppliers of the prize); and
- (d) Have not been discovered to have breached these Conditions of Entry or Conditions of Entry of previous contests run by the Promoter, ("Entrants").

An immediate family member means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child, parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

The Promoter reserves the right to verify the validity of entries and to disqualify any Entrant who tampers with the entry process or who submits an entry that is not in accordance with these Conditions of Entry. 3. All prices stated are in Australian dollars (AUD), and represent the recommended retail price ("RRP") and include GST. All references to times and dates are reflected as to times and dates in Melbourne which may be Australia Eastern Standard Time (AEST) or Australian Eastern Daylight Saving Time (AEDST) depending on the date. All times are stated using the 24-hour clock.

KEY DATES

4. The Promotion commences on **Wednesday 6 November 2019 at 09:00 AEDT** and closes **Wednesday, 25 December 2019 at 23:59 AEDT** ("Promotional Period").
5. No responsibility will be taken by the Promoter for any ineligible or lost entries or entries submitted received by the Promoter after the closing date. Entries that do not comply with these Conditions of Entry are incomplete, submitted or received by the Promoter after the closing date will be declared void.
6. The Promotion prize draw for the winner will take place at **14:00 AEDT on Thursday, 9 January 2020** at MDSA, Level 17, 40 Mount Street, North Sydney NSW 2060. The Promoter's decision in relation to any aspect of the Promotion is final and binding on every Entrant. No correspondence will be entered into.
7. The winner of the Promotion will be notified within 2 business days of the draw, by email and phone relying on the contact details provided by the Entrant and their name will be published in *The Australian* newspaper on **Thursday, 16 January 2020**.
8. **UNCLAIMED PRIZE DRAW:** The Promoter reserves the right to redraw a winner in the event of an Entrant failing to comply with these Conditions of Entry or forfeiting or not claiming the prize by 17:00 AEDT Thursday, 9 April 2020. If the prize remains unclaimed by that date, a second chance draw will be held at the same time & location as the original draw on Thursday, 16 April 2020. Disposal of the unclaimed prize may be made subject to any written directions given by any government authority and pursuant to any relevant legislation. The unclaimed prize draw winner will be contacted by email and phone within 2 business days of the draw and their name will be published in *The Australian* newspaper Thursday 23 April 2020.

HOW TO ENTER

9. To enter, Entrants must complete the following steps during the Promotional Period:
 - (a) Purchase a Gift Card or e-Gift Card from the Event Cinemas Gift Shop desktop website [www.giftshop.eventcinemas.com.au] or mobile site during the Promotional Period.
 - (b) Entrants who purchase a Gift Card or e-Gift Card through the above Event Cinemas Gift Shop desktop or mobile site during the Promotional Period will automatically be awarded one entry into the Promotion (one entry per transaction).
 - (c) Only one opportunity to enter will be awarded per transaction (not per Gift Card or e-Gift Card purchased).

10. Any cost associated with accessing the Promotion website is the Entrant's responsibility and is dependent on the Internet service provider used.
 11. The prize will be awarded by a random draw conducted by MDSA on behalf of the Promoter.

ENTRY REQUIREMENTS & VERIFICATION

12. The Promoter may, at their absolute discretion, disqualify any Entrant and declare any or all entries made by an Entrant invalid if Entrants:
 - a) Tamper with the entry process, including use of any automated entry software or any other mechanical or electronic means that permit the Entrant to automatically enter repeatedly; or
 - b) Tamper with the operation of the Promotion or web site or found to be using multiple aliases, household addresses or email addresses; or
 - c) Act in a disruptive manner; or
 - d) Fail to establish their entitlement to enter the Promotion to the Promoter's reasonable satisfaction; or
 - e) Fail to produce items as required or produces items that, in the Promoter's opinion, are illegible, stolen, forged, reconstructed, altered, incomplete or tampered with in any way; or
 - f) Act in violation of these Conditions of Entry.

ENTRY DETAILS

13. Entrants can only enter in their own name.
14. Entries are deemed to be received at the time of receipt in the Promotion database and NOT the time of transmission by the Entrant.
15. Incomplete, illegible or incorrect entries, entries which are not in the required format or which contain offensive or defamatory comments, or which breach any law or infringe any third party rights, including intellectual property rights, are not eligible to win the prize.

PRIZE POOL

16. One (1) Major Prize will be drawn for Australia (excluding VIC and TAS):

Major Prize Details

- Return economy flights (2 adults, 2 children aged 15 years or younger) from winner's nearest Australian capital city to Gold Coast, Queensland (flight associated taxes are included).
- Return airport / hotel transfers in Gold Coast
- Four (4) nights' accommodation for four people (minimum 4 star property as selected by the Promoter)
- Three (3) day Dreamworld & White Water World entry pass for four people (2 adults, 2 children aged 15 years or younger)

PRIZE CONDITIONS

17. Package is based on four (4) people sharing a room.
18. Private Ghost Tour not recommended for children under eight (8) years of age. A waiver will need to be signed prior to booking if children are under eight (8) years of age.
19. Unless otherwise stated, winner and guest/s are to make their own way to and from all prize inclusions.
20. All elements including flights, accommodation and experiences are subject to availability at time of booking. There is no cash alternative. Prize is non-refundable and non-transferable.

PRIZE WINNER

 45. The prize, or any unused portion of the prize, is not transferable or exchangeable and cannot be taken as cash. In the event of war, terrorism, state of emergency or disaster, the Promoter reserves the right to cancel, terminate, modify or suspend the Promotion, subject to state regulations.
 46. The Promoter accepts no responsibility for any tax implications that may arise from the prize winnings. Independent financial advice should be sought by the winner.
 47.  48. The Promoter will not be responsible for:
 - a) Malfunction, delay or traffic congestion on any telephone network or line, computer on-line system, servers or providers, computer equipment, software, or website;
 - b) Failure of any entry to be received by the Promoter as a result of those matters; nor
 - c) Any injury or damage to Entrants or any other person related to or resulting from participation in the Promotion or downloading any materials relating to the Promotion.
 49. The Promoter accepts no responsibility for any late, lost or misdirected entries due to technical disruptions, network congestion or for any other reason.
 50. The Promoter reserves the right in their sole discretion to disqualify any individual who the Promoter has reason to believe has breached any of these Conditions of Entry, or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
 51. The Promoter and their associated agencies and companies assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission; communications line failure, theft or destruction or unauthorised access to, or alteration of entries, and reserve the right to take any action that may be available.
 52. To the extent permitted by law, the Promoter, their employees and agents are not liable for any loss suffered to person or property by reason of any act or omission, deliberate or negligent, by the Promoter or their employees or agents, in connection with the arrangement for the supply, or the supply, of goods and services by any person to the prize winner and, where applicable, to any persons accompanying the prize winner. This clause does not affect any rights a consumer may have which are unable to be excluded under Australian law.
